2. Personal data You provide will be kept in a file under the responsibility of FASHION RETAIL, S.A. for the purposes of:
  - i. the performance and enforcement of the purchase and sale contract over the products You have purchased, or of any other contract between You and us;
  - ii. attending to Your requests, and
  - iii. providing You with information about the products of Bershka, Zara or of any other company belonging to the Inditex Group (whose objects are related to the decoration, textile, finished fashion and homeware products sectors, and to any other objects supplemental to the above, including cosmetics and leather goods), including, as regards the above referred products, sending commercial communications by e-mail or by any other equivalent electronic communication means (such as SMS) as well as phone calls. You can change your preference in respect of receiving such communications by logging into the MY ACCOUNT section of this website and editing your preferences.
